• Stipendiary Trainees: The application fee shall be paid online through the payment gateway system provided in the online Application at the rate of Rs.100/-(Rupees Hundred only) for SC/ST category and Rs.200/-(Rupees Two Hundred only) for others.

- Only SC/ST caste categories listed in the Kerala PSC will be considered. Applicants from other states belonging to SC/ST categories, not listed in the Kerala PSC will be considered as General category.
