6. Candidate should apply ONLINE through our website [www.mcc.kerala.gov.in](http://www.mcc.kerala.gov.in) . Last date of Online Application is **30/08/2025, 12.00 PM.**

8. **Application Fee:**
- **Contract:** The application fee shall be paid online through the payment gateway system provided in the online Application at the rate of **Rs.100/-(Rupees hundred only) for SC/ST category and Rs.250/-(Rupees Two hundred and fifty only) for others.**
  - **Only SC/ST caste categories listed in the Kerala PSC will be considered.** Applicants from other states belonging to SC/ST categories, not listed in the Kerala PSC will be considered as General category.
9. The following provisions of age relaxation shall be applicable:
- Other Backward Classes(OBC):Relaxation of 3 years on the upper age limit.
  - Scheduled Castes/ Scheduled Tribes (SC/ST): Relaxation of 5 years on the upper age limit
  - Ex-Servicemen: Age limit extended up to 50 Years.
