For stipendiary trainees posted in MCC - PGIOSR will be one year initially and can be extended for a maximum period of 3 years of 179 days with a break, subject to satisfactory performance (Maximum 5 tenures).

- **Contract:** The application fee shall be paid online through the payment gateway system provided in the online Application at the rate of Rs.50/-(Rupees fifty only) for SC/ST category and Rs.250/-(Rupees Two hundred and fifty only) for others.
  - **Stipendiary Trainees :** The application fee shall be paid online through the payment gateway system provided in the online Application at the rate of Rs.00/-(Rupees zero) for SC/ST category and Rs.100/-(Rupees Hundred only) for others.
  - **Only SC/ST caste categories listed in the Kerala PSC will be considered.** Applicants from other states belonging to SC/ST categories ,not listed in the Kerala PSC will be considered as General category.
9. Candidates should produce the **originals Certificate** along with a **self attested copy** of the same at the time of interview.
