1. Application received after the due date will not be considered under any circumstances. Details regarding the interview date will be informed later. There may be a screening test if the number of candidates more than 5 per course. The marks obtained in screening test will not be used for selection except in case of tie in interview.
2. Any attempt at influencing any official of MCC will be a straightforward reason for outright rejection of the application. Such candidates will be debarred for a period of 5 years from applying to any post in MCC.
3. No TA/DA etc. will be given to attend the Interview and out Stationed candidate should make his/her own arrangement for stay for interview and joining of post, if offered
4. Qualification and experience should be from a recognized University or organization (Recognized by Central or state Government)
5. Age will be calculated as on 1st January of the year. ie **01-01-2025**

 - i. Your photograph in digital form with the following specifications;
 - Maximum Image Size: 30Kb
 - Image Dimension: 150W X 200H px
 - Image Type: .jpg format
 - ii. Reference number for application fee is Rs. 100 / - for SC / ST category and Rs. 500 / - for others. The application fee shall pay online through the payment gateway system provided in the online Application
3. The last date of submission of ONLINE is **23th August 2025** till 5 pm
4. Candidates claiming fee concession/exemption, a copy of SC/ST Certificate from the competent authority, shall be submitted at the time of interview. Else the candidate may pay the pay for the general category

5. Incomplete applications will not be considered, and no individual notifications will be sent.
6. Selection will be based on qualification and performance in the Test/Interview. Claims in respect of Qualification should be supported by copies of relevant documents; Candidates should produce the originals at the time of interview
7. The application will be screened and eligible candidates will be informed through email (with date & venue) to attend the interview.
